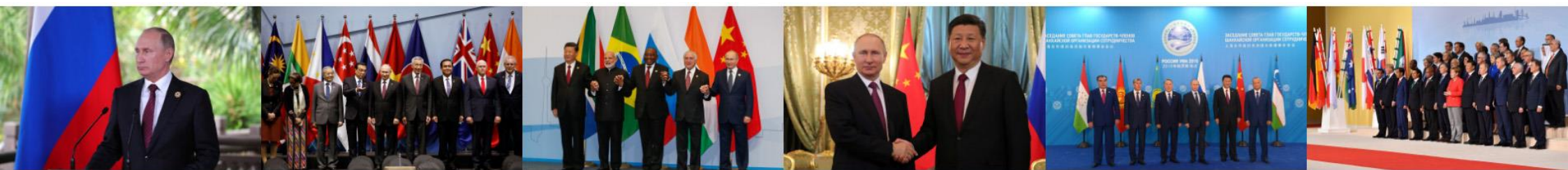

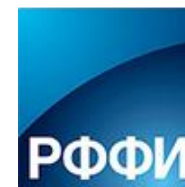


## About

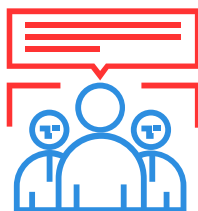

## About



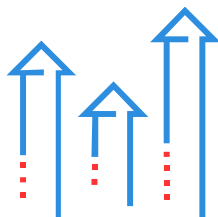

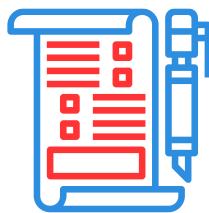
## Targets

5. **Creating**. The establishment of competence centres in the Russian Federation, with the aim of attracting investment and creating innovative industries, in accordance with the approved Regulation on the development and operation of Eurasian technology platforms (ETP);
6. **The promotion** of continuous technological upgrade in the priority sectors of the Russian economy;
7. **The increase** of the global competitiveness of the national industry within the Eurasian Economic Space;
8. **The promotion** of the Russian Federation interests, of the domestic technological and business projects, as well as educational programs in the near and far abroad countries;
9. **Participation** in shaping of the future economy..



## Activity

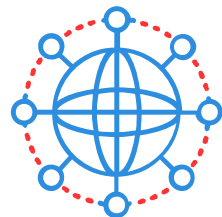
